PARTICIPANT INFORMATION

As a Boater, you will be paired with a Co-Angler or Observer. Based on the number of participants, Boaters may not be paired with another angler and will be permitted to fish alone. Boaters will only compete against other anglers registered in the Boater Division. All Boater Division prizes are based on the entry fees collected only from that Division.

As a Co-Angler, you will be paired with a Boater. If the number of Co-Anglers registered for an event exceeds the number of Boaters, Co-Angler eligibility will be based on the earliest registered Co-Anglers. Co-Anglers will only compete against other anglers registered in the Co-Angler Division. All Co-Angler Division prizes are based on the entry fees collected only from that Division.

The only things necessary for you to bring with you, as a Co-Angler or Observer, will be your fishing tackle and a Coast Guard approved life vest. If you are new to the sport of bass fishing tournaments, this is your opportunity to fish a professional type tournament at a very reasonable expense. Your support as a Co-Angler is very critical to the success of any tournament. We are sure that a whole new world will open for you when you enter these events.

At the end of the season the top six Boaters and the top six Co-Anglers in points will qualify and be eligible to compete at a 2016 TBF National Semi-Final event.

BE AN OBSERVER!

When participating in a tournament as an Observer there is no fee, only an optional Lunker Pool entry fee (\$5 for one-day event; \$10 for two-day event). The Tournament Director must receive the Lunker Pool fee by the Application Deadline listed on this form. Observers are not eligible for any points or additional prizes.

The top six Boaters and top six Co-Anglers at the end of the year are eligible for a 2016 TBF National Semi-Final event.

Co-Anglers

Co-Anglers are assigned via random boat draw and, depending on the number of participants, not all Boaters will be assigned a Co-Angler.

If there are more registered Co-Anglers than Boaters, eligibility to fish on tournament day will be based on the Co-Angler with the earliest registration date for the event.

THIS RELEASE IS LEGALLY BINDING EVEN IF YOU ARE INJURED OR KILLED DUE TO THE NEGLIGENCE OR WRONGFUL CONDUCT OF The New Jersey Bass Federation AND/ OR THE Bass FEDERATION, INC., AND/OR THEIR MEMBERS, DIRECTORS AND OFFICERS.

GENERAL RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT

having read the above Notice, understand that by signing this release and waiver of rights I am giving up my right to sue New Jersey Bass Federation, their members, directors and officers and releasing them and holding them harmless even from the effects of their own negligence, for any personal injuries I may sustain while participating in a New Jersey Bass Federation and/or THE Bass FEDERATION fishing tournament. I understand that this release is legally binding and even if I am injured or killed due to the negligence or wrongful conduct of New Jersey Bass Federation and/or THE Bass FEDERATION, and/or their members, directors and officers, that I cannot sue or make any claim to recover for such injuries. (If someone intentionally injures me, this release will not prevent me from suing them or making a claim for personal injuries.) This release is intended to be binding upon my spouse, my estate, my personal representative and/or my beneficiaries or dependents.

I understand that there is good and valuable consideration for the making of this release. I understand that I am giving up the right to sue my fellow members of New Jersey Bass Federation and/or THE Bass FEDERATION and that they are giving up the right to sue me.

I understand that I do not need to sign this release waiver and hold harmless agreement, and that I am not forced to sign this release and waiver. However, unless I sign this waiver, intending it to be binding, I cannot participate in the fishing tournament.
