1. Boat numbers will be assigned in order of receipt of registration. **Want a low boat number? Register early!**
2. Fish alone or with a partner.
3. All boat operators must possess valid boater liability insurance. Proof of insurance may be requested by a tournament official at any time. Failure to produce insurance upon request is cause for disqualification.
4. 12-inch minimum size per fish. Five fish per boat limit. Largemouth and smallmouth bass only.
5. All participants must possess a valid New Jersey Fresh Water Fishing license.
6. No refunds for any reason other than cancellation of the event.
7. All participants **must read the attached release (see reverse)**. By participating in this event is considered approval of the terms outlined in that release.

# THE NEW JERSEY BASS FEDERATION RELEASE FORM WITH WAIVER

## *GENERAL RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT*

**TAKE NOTICE**, BY READING THIS RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT, AND PARTICIPATING IN THE FISHING TOURNAMENT CONDUCTED BY THE NEW JERSEY BASS FEDERATION (NJBF) ON **APRIL 14, 2019 AT LAKE HOPATCONG, MOUNT ARLINGTON, NEW JERSEY**, YOU ARE GIVING UP YOUR RIGHT TO SUE THE NJBF AND/OR THE BASS FEDERATION (TBF), THEIR MEMBERS, DIRECTORS AND OFFICERS AND ARE RELEASING THEM FROM ALL ACTIONS, CLAIMS AND LIABILITIES, AND EVEN FROM THE EFFECTS OF THEIR OWN NEGLIGENCE. THIS RELEASE IS LEGALLY BINDING EVEN IF YOU ARE INJURED OR KILLED DUE TO THE NEGLIGENCE OR NON-INTENTIONAL WRONGFUL CONDUCT OF THE NJBF AND/OR THE TBF AND/OR THEIR MEMBERS, DIRECTORS AND OFFICERS.

I have read the above Notice and understand that by participating in the above event, I am giving up my right to sue the NJBF and/or the TBF, their members, directors and officers and releasing them and holding them harmless even from the effects of their own negligence, for any personal injuries I may sustain while participating in the event. I understand that this release is legally binding, and even if I am injured or killed due to the negligence or non-intentional wrongful conduct of the NJBF and/or the TBF, and/or their members, directors and officers, that I cannot sue or make any claim to recover for such injuries. I acknowledge that if someone **intentionally** injures me, this release will not prevent me from suing them or making a claim for personal injuries. This release is intended to be binding upon my spouse, my estate, my personal representative and/or my beneficiaries or dependents.

I understand that there is good and valuable consideration for the making of this release. I understand that I am giving up the right to sue members of NJBF and/or the TBF and likewise they are giving up the right to sue me.

I understand that by participating in the event, I am willingly and voluntarily agreeing to all components of this release, waiver and hold harmless agreement, and intend it to be binding. I cannot participate in the fishing tournament conducted by the NJBF on **April 14, 2019 at Lake Hopatcong, Mt. Arlington, New Jersey** without such acknowledgment and verify that I have read the above Release, Waiver, and Hold Harmless Agreement, and understand its contents.
